

## PEPSI – GET IT WHILS IT’S HOT SWEEPSTAKES

### Official Rules

**NO PURCHASE NECESSARY. MESSAGE AND DATA RATES MAY APPLY. VOID WHERE PROHIBITED.**

**1. SWEEPSTAKES PERIOD:** Sweepstakes begins at 12:00:00 a.m. ET (midnight) on 5/3/17 and ends at 11:59:59 p.m. ET on 7/4/17 (“Sweepstakes Period”).

**2. HOW TO ENTER:** During the Sweepstakes Period, you can enter via the following method: **(a) TEXT MESSAGE:** Use your mobile phone to text “CONCERT” to 52140 and you will be automatically entered into the Sweepstakes. Participants must have a mobile phone with text messaging capabilities to enter by text message and may incur standard text message and data charges from their wireless service provider for each message sent and received. Approximately a total of three (3) text messages will be required to participate. Check with your wireless service provider for details on any applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. By entering this sweepstakes via text messaging the entrant is consenting to receive text and phone messages regarding the Sweepstakes. To enter without official mail-in form, hand print your name, complete street address, date of birth and daytime phone number on a 3½ x 5 inch paper. Each entry must be mailed separately in a hand-addressed, stamped envelope. No photocopied or mechanically reproduced entries accepted. Limit one (1) text message entry per person/mobile phone number per day and one (1) mail-in entry per person/household per day. A “day” is defined as a twenty-four (24) hour time period beginning at 12:00:00 a.m. (midnight) ET and ending at 11:59:59 p.m. ET. The time clock of the Sweepstakes administrator is the official clock for this Sweepstakes. If entering via text message, the person submitting the Sweepstakes entry must be the authorized account holder/user of the mobile phone number, or otherwise entry shall be deemed void. In the event of dispute over the identity of a potential winner, entries will be declared made by the registered user of the mobile phone number used at the time of entry, and potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder/user of the mobile phone number submitting the entry. In the event of dispute over the identity of a potential winner, an online or text message entry will be declared made by the authorized account holder of such email address or wireless phone number submitted at the time of entry, and potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of such email address or wireless phone number. or postal address during the Sweepstakes Period. Proof of emailing/texting does not constitute proof of delivery or entry. If a potential prize winner is notified by text, email or phone, he/she will be required to respond within seventy-two (72) hours or prize will be forfeited and may be awarded to an alternate winner. Sponsor is not responsible for suspended or discontinued wireless service that may result in a potential winner not receiving initial prize notification. Once potential winner notification is confirmed to Sponsor, the potential prize winner may be sent an Affidavit of Eligibility and Liability/Publicity Release to be signed and returned within the number of days indicated on the Affidavit. In the event (i) the attempted notification is returned as undeliverable without a forwarding address; (ii) a telephone or text message notification is not confirmed to Sponsor within seventy-two (72) hours; (iii) any required documents are not returned within the required number of days; or (iv) if winner is otherwise unable to attend an event when specified or accept the prize as stated, prize will be forfeited and may be awarded to an alternate winner.
